Freight forwarders: the "Architects of Transport"

Freight forwarders ensure the resilience and continuity of global supply chains, acting as a single trusted partner for end-to-end multimodal transportation



- "Architects of Transport" amid global uncertainty
- Expertise and know-how to find the most efficient and effective routes and transport modes amid disruptions – the key to building resilience
- Crucial partner for shippers, ensuring unique understanding on customer needs worldwide
- Possibilities for full load or consolidation of multiple shipments gives MSMEs the opportunity to access international supply chains at competitive prices

In 2022, FIATA launched the FIATA Digital eFBL (Digital FIATA Bill of Lading), accessible through Members' everyday tools, helping them to save time and money while bringing trust and security to their partners



Digital multimodal transport documents such as the eFBL are important tools to strengthen transport and trade corridors:

- 1 single document to provide to the bank, irrespective of the modes of transport used, and ensuring quick goods release at the destination.
- Secure, immutable nature of the Digital eFBL eliminates concerns of fraud, uncertainty and lost documents.
- **Digitalisation** unleashes new trade facilitation measures for efficiency, cost-savings, accessibility and business continuity.
- Need to **ensure future-proof, interoperable approach** that facilitates access for stakeholders across the supply chain, including SMEs.



Supporting multimodal transport corridors

FIATA supports the development of resilient multimodal transport corridors globally

Strengthening transport possibilities through negotiable multimodal transport documents

- Ongoing work at UNCITRAL to strengthen legal recognition of negotiable multimodal transport documents and to help secure access to trade finance
- Promoting and strengthening FIATA multimodal transport bill of lading (paper/digital) through industry collaboration and mapping of data standards (UN, WCO)

Trade facilitation: Working towards more streamlined customs operations at border crossing

- Providing industry recommendations at the intergovernmental level through the WCO and WCO-PSCG, e.g. on trade facililitation, AEO programmes, digitalisation
- Supporting industry in the implementation of PLACI regimes

Building resilient and well-functioning corridors through international collaboration

• Fostering international dialogue and regional collaboration on key trade corridors such as Middle and Southern Corridors and **China-Europe routes**, in collaboration with UNECE, UIC, OTIF, CIT, OSJD, FIATA Association Members, local organisations, etc.



Strengthening regional transport connectivity in the Middle Corridor region

- Knowledge sharing events: creating platforms for stakeholder discussion, such as FIATA-UIC Market Place Seminar focused on the Middle and Southern Corridors (Nov 2023)
- Transport corridor development: development of a toolkit on transport/freight corridor advancements and recommendations
- Collaboration for promotion of rail transportation: FIATA works closely with global and regional organisations, to promote the development of international freight traffic between Europe and Asia: International Union of Railways, UIC, Organization for Cooperation of Railways, OSJD; UNECE, OECD/ITF, OTIF, CIT, etc.



Importance of airfreight in multimodal strategies

Airfreight is becoming increasingly essential for navigating disruptions and capacity limits for the Central Asia region

Airfreight is becoming fundamental for the region, not just a backup option

- Currently, all Central Asian countries record an increase in cargo transportation
- Tighter ocean capacity from Asia into Europe during peak season, combined with the continuing situation in the Red Sea, is driving up demand and rates for air freight from Asia Pacific and the Middle East
- Important role of consolidators, such as international freight forwarders specialising in air cargo and local forwarders with international connections
- Crucial to develop long-term freight and logistics plans that incorporate a multimodal approach. This requires stakeholder collaboration and consultation between governments and industry

Building a stronger, more resilient airfreight industry

FIATA continues to work towards advancing air cargo standards and operational efficiency globally through various strategic initiatives

Ensuring harmonised, practical air cargo frameworks worldwide

- Working closely with national authorities and industry on the development and implementation of PLACI regimes
- Providing industry input within the IATA-FIATA Consultative Council (IFCC) and working towards a global air cargo programme for all regions

Ensuring an efficient, safe and secure air cargo

- Promoting and ensuring DGR certification and compliance of freight forwarders
- Providing practical industry input on operational processes for greater efficiency

Fostering training for the industry of today and the future

- Delivering ICAO-FIATA Dangerous Goods by Air Training Programme
- Providing accessible training programmes (FIATA Diplomas) for freight forwarders of all sizes
